#### 1 Name

This determination is the Australian Sports Commission Determination 2023/1.

# Schedule 1—Amendments

### Australian Sports Commission Determination 2021/1

#### 1 Section 10

Repeal the section, substitute:

#### 10 Third annual adjustment of salary

(1) Employees' salaries are adjusted by 3.00%, with effect on 1 June 2023.

Note: The rate of this adjustment is provided under the *Public Sector Interim Workplace Arrangements 2022*, as advised by the Australian Public Service Commission.

- (2) Each adjustment is to be calculated based on the salary immediately before the adjustment under subsection (1).
- (3) Schedule 3 has effect.
- (4) This section and Schedule 3 have effect despite section 8 and 9 and Schedules 1 and 2.

#### 2 Schedule 3

Repeal the Schedule, substitute:

# Schedule 3 —Third annual adjustment—Salary on 1 June 2023

Note: See section 10.

#### 1 Salary

On 1 June 2023, salary for an employee covered by column 1 of an item of the following table at a pay point described in column 2 of the item is payable at the rate for that pay point (the *new rate*) described in column 3 of the table. This is an adjustment of 3.00% under subsection 10(1) of this determination.
