1 Name

Schedule 1—Amendments

Australian Sports Commission Determination 2021/1

1 Section 9

Repeal the section, substitute:

9 Second annual adjustment of salary

(1) Employees' salaries are adjusted by 1.9%, with effect on 1 June 2022.

Note: The rate of this adjustment is the applicable WPI – Private Sector Adjustment for the period as advised by the Australian Public Service Commission.

(2) Each adjustment is to be calculated based on the salary immediately before the adjustment under subsection (1).

(3) Schedule 2 has effect.

(4) This section and Schedule 2 have effect despite section 8 and Schedule 1.

2 Schedule 2

Repeal the Schedule, substitute:

Schedule 2—Second annual adjustment—Salary from 1 June 2022

Note: See section 9.

1 Salary

From 1 June 2022, salary for an employee covered by column 1 of an item of the following table at a pay point described in column 2 of the item is to be payable at the rate for that pay point (the *new rate*) described in column 3 of the table. This is an adjustment of 1.9% under subsection 9(1) of this determination.
